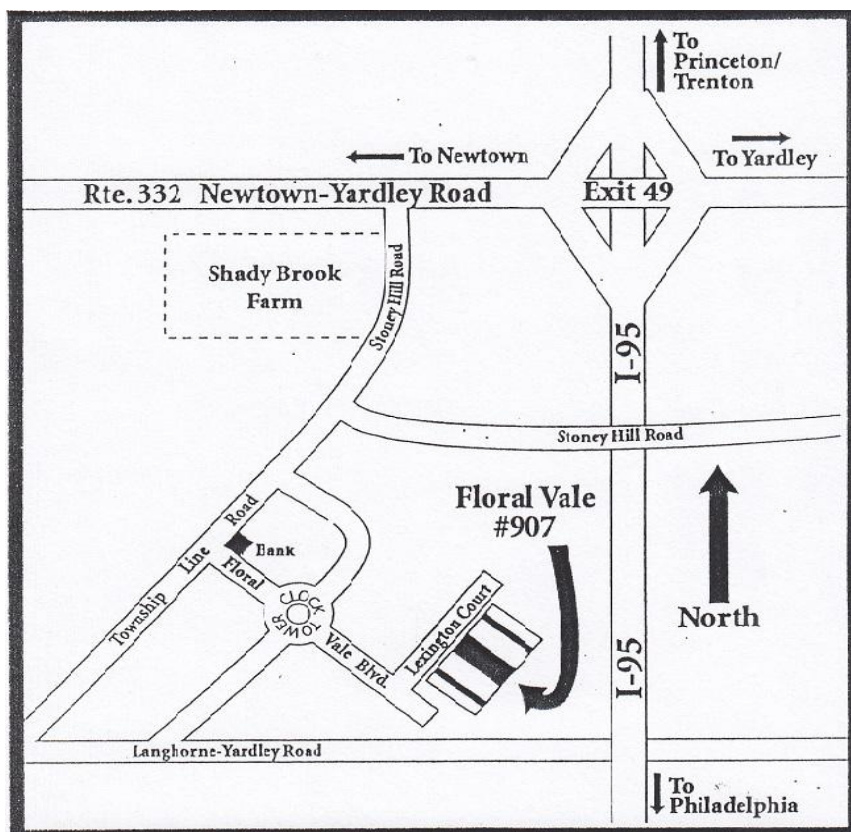
## DIRECTIONS TO 907 FLORAL VALE BOULEVARD

### NEWTOWN-HOLLAND-RICHBORO AREA

- Get onto the Newtown Bypass (Rte. 332 East)
- Turn RIGHT onto Stoney Hill Road
- Continue STRAIGHT at next TRAFFIC LIGHT
- Stoney Hill Road becomes Township Line Road
- Turn LEFT at the FULTON BANK – (Floral Vale Professional Park)
- At the CLOCK TOWER, go ½ way around circle to rear
- Turn LEFT into LEXINGTON COURT and continue to SUITE 907

### LEVITTOWN-BRISTOL-LANGHORNE AREA

- Go North on Oxford Valley Road
- At the Traffic Light after Kohl's Department Store, turn LEFT
- You are now on Big Oak Road, which turns into Township Line Road
- Continue STRAIGHT to next Traffic Light (Yardley-Langhorne Road)
- Continue STRAIGHT thru Light and Turn RIGHT at Floral Vale Entrance (Look for FULTON BANK on RIGHT)
- At the CLOCK TOWER, go ½ way around circle to rear
- Turn LEFT into LEXINGTON COURT and continue to SUITE 907



### PHILADELPHIA AREA

- Take I-95 NORTH to EXIT 49 Newtown/Yardley
- Turn LEFT onto Rte. 332 WEST, towards Newtown
- Turn LEFT onto Stoney Hill Road
- Continue STRAIGHT at next TRAFFIC LIGHT

### NEW JERSEY AREA

- Take I-95 SOUTH to EXIT 49 Newtown/Yardley
- Turn RIGHT onto Rte. 332 WEST towards Newtown
- Turn LEFT onto Stoney Hill Road
- Continue STRAIGHT at next TRAFFIC LIGHT

- Stoney Hill Road becomes Township Line Road
- Turn LEFT at Entrance of FULTON BANK (Floral Vale Professional Park)
- At the CLOCK TOWER, go ½ way around circle to rear
- Turn LEFT into LEXINGTON COURT and continue to SUITE 907
